INVITATION FOR PRE-QUALIFICATIONS FOR SUPPLY AND PROVISION OF VARIOUS SERVICES

- 1. The East, Central and Southern Africa Health Community (ECSA-HC) is a health Regional Intergovernmental Organization mandated to foster Regional Cooperation for better Health in ECSA region. The current member states are Kenya, Lesotho, Malawi, Mauritius, Eswatini, Uganda, Tanzania, Zambia and Zimbabwe.
- 2. The ECSA-HC has set aside funds for financial year 2023/2024 toward the cost of operations and implementation of its programmes. It is intended that part of the funds will be applied to eligible payments under the contracts for the supply of goods and provision of services for two financial years 2023/2024 2024/2025.
- 3. ECSA-HC Secretariat invites applications for Pre-Qualifications from the eligible, highly competent and experienced Suppliers and Service Providers within the United Republic of Tanzania under the listed categories.
- 4. The Selection and final short listing of suppliers and service providers will be conducted through the Competitive Tendering Procedures as specified in the ECSA-HC Procurement Policy and Procedures. Only shortlisted suppliers and service providers will be eligible for invitation to quote under competitive procedures each time when the ECSA-HC will be in need of the specified services and goods.
- 5. The selection Criteria shall involve Legal registration/compliance and Capabilities.

a. Legal Registration/Compliance

- Possession of registration certificates from relevant authorities
- Submission of business license, company certificate of incorporation, Tax Identification Number (TIN)
- Current physical location which will be inspected for verification); that is a valid right of occupancy of office premises or lease contract
- Submission of CERTIFIED power of attorney document

b. Company's Capabilities, Proposed Solution and Methodology

- The company must have not less than three years' experience in the relevant field.
- Staffing levels; must submit the list of key staff with their CVs demonstrating their ability to carry out the assignment.
- Financial Capability (submit the latest Five months bank statements).
- Demonstrate capability in terms of equipment, skills and technology as per requirement in respective categories if applicable.

Please note that in assessing the submissions, consideration will be given to the firm with ability to meet requirements such as Legal Registration/Compliance and Company's Capabilities. Only eligible and qualified Bidders with demonstrated experience and excellent track record in similar assignments will be considered for prequalification.

- 6. In case of any further clarification required, the interested qualified firm may obtain further clarification information from the Office of Director General from 0800 to 1700 hours Monday to Friday except on public holidays. ECSA-HC will respond to the request for clarifications received within Five (5) days prior to the deadline for submission of application.
- 7. The pre-qualification is of Twenty-Four (24) lots and each lot is independent, Suppliers and service providers may apply for a single lot, multiple lots or all twenty-Four (24) lots and pre-qualification will be on lot basis as follows:

- 10. Late Tenders, Portion of Tenders, Electronic Tenders, Tenders not received, Tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
