The EU-Africa project on Personalised Medicine (EU-Africa PerMed) welcomes you to the first ever newsletter.

To set the stage, we want to start by giving a brief background about our cutting edge project, themed "Building Links between Europe and Africa in Personalised Medicine".

As per the project name, we are aiming at integrating African countries into CPerMed activities, envisaged to contribute to a successful implementation of Personalised Medicine (PM) in the global context and foster joint PM projects and programmes between Europe and Africa, as well as strengthening bilateral EU-AU science, technology and innovation (STI) relations in the area of health.

The EU-Africa PerMed is four (4) year project that was launched on the 1st of February 2021 and implemented by a consortium of 13 partners from both Europe and Africa.

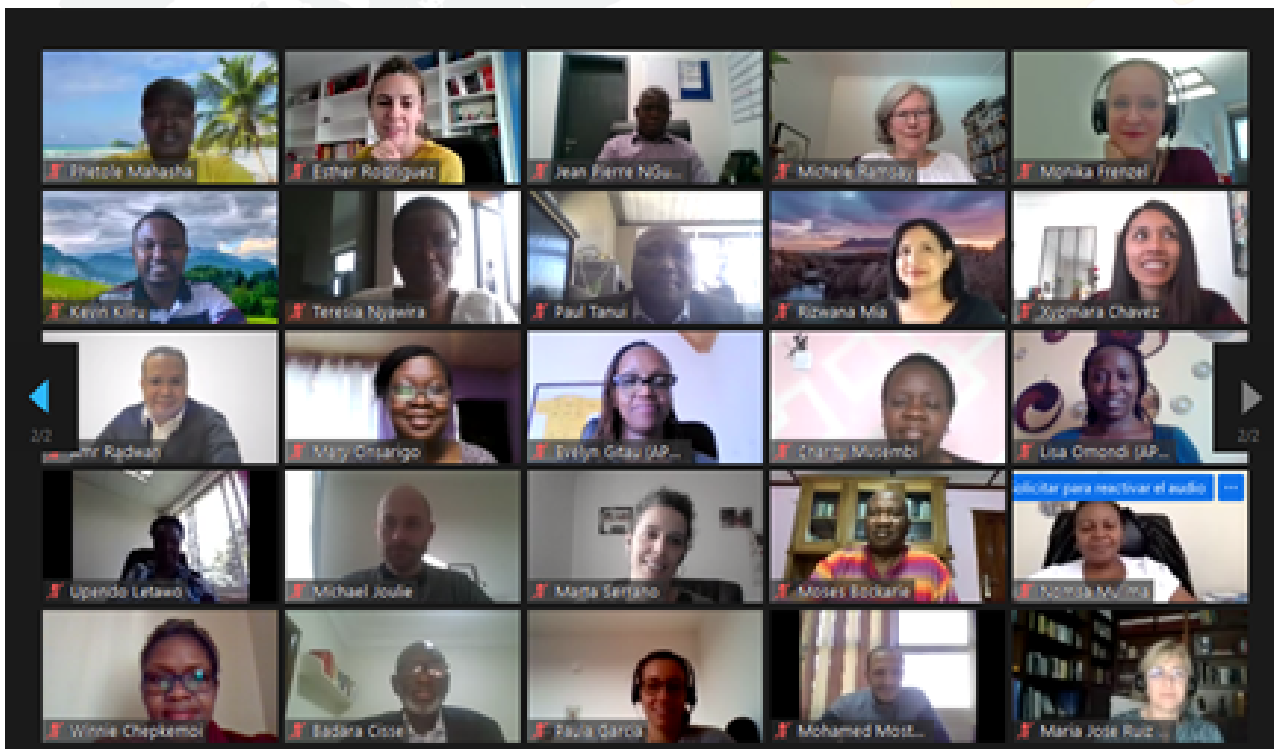

EU-AFRICA PERMED LAUNCHES THE PROJECT



2021 marked a greater milestone to this ground-breaking project themed "Linking Europe to Africa in Personalized Medicine". The project kick-off meeting took place on the 4th of March 2021. Due to the COVID19 pandemic and existing travel restrictions, the meeting took place online, using the ZOOM platform. The meeting was hosted by the project coordinators INNOVATEC.

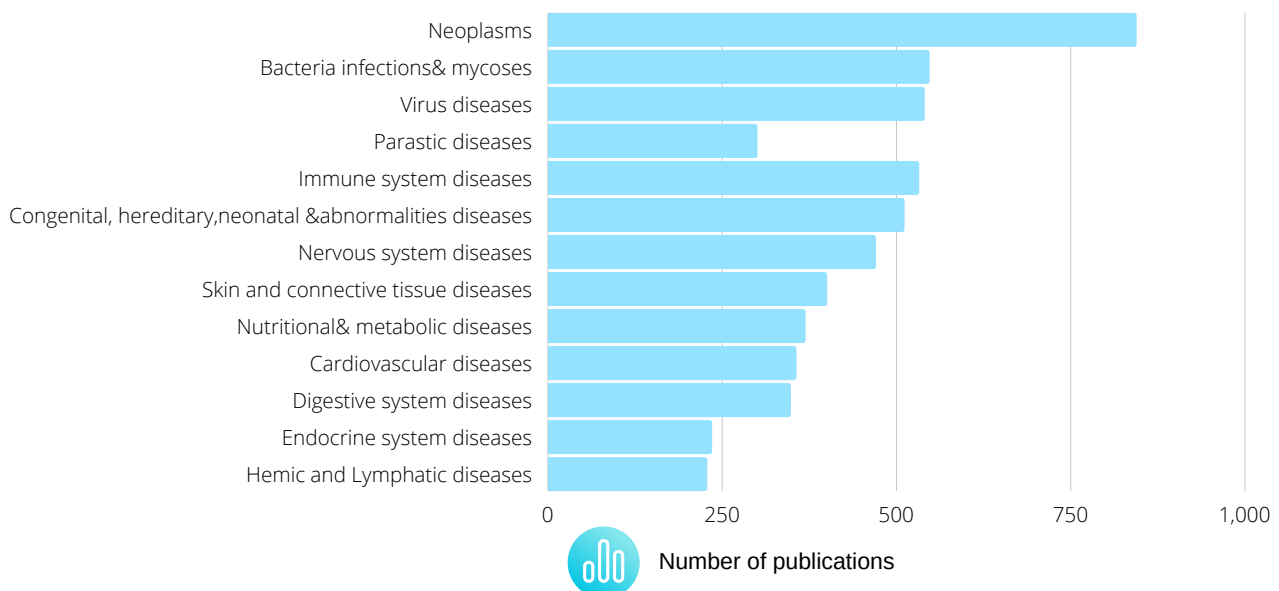
During this meeting, consortium members agreed to use one definition for Personalized Medicine, as used by the European council "a medical model using characterization of individuals' phenotypes and genotypes (e.g. molecular profiling, medical imaging, lifestyle data) for tailoring the right therapeutic strategy for the right person at the right time, and/or to determine the predisposition to disease and/or to deliver timely and targeted prevention".



RESULTS OF THE SCIENTIFIC AND POLICY MAPPING EXERCISE RELEASED

We are excited to share the preliminary findings of the Scientific and Policy Mapping exercise which the project was conducting since February 2021. The study was commissioned to gain knowledge on health, Research and Innovation and on policy landscape in Africa with specific focus on Personalized Medicine.

The review also found that there is an increase in the number of articles between 2011 and 2020, even more evidenced when comparing Bacterial infection related publications (14-times increase), followed by Cardiovascular (11-times increase), and virus diseases (almost 8-times increase).



This is also one of the project deliverables. We deployed two main tasks to gather the information: Bibliometric analysis of recent scientific literature to describe the scientific landscape of Personalized Medicine (PM) in Africa and Review of health R&I policy landscape in African countries.

As a summary, almost 82% of the articles found were related to the 13 disease categories as highlighted on figure above, predominantly infectious diseases, followed by cancer, immune systems and nervous system diseases.

The South African and Egyptian institutions: University of Cape Town, Cairo University, University of Stellenbosch, South African Medical Research Council and Ain Shams University are the leading institutions with respect to the number of articles.
